3. Vice-Presidents Report

The structure of the junior program was praised for being "more relaxed and fun," while still establishing good pathways for development.

Surprisingly, the junior division boasted more participants (46) than the senior division.

Gender diversity was notable, with five females ranking in the top 10 try scorers.

Representatives from the club played for Western Australia in state championships, showcasing the talent nurtured within the club.

The end-of-year wind-up event was well-received, providing a positive conclusion to the season.

Participation in the North West Championships was enjoyable, with a significant presence of new faces.

Infrastructure and Sportsmanship

Concerns were raised about the condition of the grounds, particularly one field deemed unsafe. It was noted that the local shire needs to address this issue promptly.

The season was marked by exceptional sportsmanship, with a more social atmosphere enhancing the overall experience for participants.

Special Recognition

Mick received commendation from the Oceanic Line Marking Association of Oceania, which was celebrated and congratulated by all attendees.
